The event is part of the training series **“EL@N - EU L@w for Notaries, Notaries for EU L@w”** which is co-financed by the European Union.

The training seminar is open to all Italian and German notaries, notary assistants, notary clerks and judges and will deal with the latest questions on European company law. For more information, please see the attached **programme**.

Participation is free of charge. The event will be simultaneously interpreted into German, Italian and English.

Please **register** by sending the attached **registration form** to registration@bnotk.de by **18 February 2022**. As the number of seats is limited, please let us know whether you prefer to attend in person or via videoconference. Please note that all applicable health and safety measures will be observed. Access information for the virtual event and further instructions for online participation will be sent out prior to the event.

Due to the current COVID-19 regulations, training seminars related to continuing professional development are currently only permissible in person with **proof of vaccination or recovery from COVID-19**. As the organiser, the German Federal Chamber of Notaries is therefore obliged to check proof of vaccination or recovery. This will be done during registration on the day of the event. Those who have not been vaccinated or have not recovered will not be able to attend the event. If a vaccination is not possible for medical reasons and this can be proven with a medical certificate (in original form) at registration on the day of the event, participation is possible with additional proof of a negative PCR test (with the test having been carried out no more than 48 hours before).

All participants are required to wear a face covering (FFP2 mask) if the minimum distance of 1.5 metres cannot be maintained, especially in areas where people are moving around. Thank you in advance for your cooperation.

Important information regarding the entry into Germany:

Due to the COVID-19 pandemic, a digital registration form must be completed at www.einreiseanmeldung.de before entering Germany from **high-risk or virus variant areas**. Confirmation of registration must be presented in electronic form (PDF) or in paper form upon arrival. You are not obliged to quarantine when entering Germany from **a high-risk area** should you submit proof of vaccination or recovery via the entry portal in advance. Entry from **a virus variant area** requires mandatory quarantine for fourteen days.

The list of high-risk and virus variant areas is subject to change and can be found at www.rki.de/risikogebiete.

We will keep you informed about the COVID-19 regulations and reserve the right to make changes.

Room bookings can be made directly with the Sofitel Hotel Munich Bayerpost at a guaranteed contingency rate of €235 per night/person (single room including breakfast) until **10 February 2022** using the booking reference "Training IV". Cancellations are possible up to 3 March 2022, after which 90% of the room rate will be charged.
