1. Responsible authority

3. Processing of personal data

When collecting, processing and using your personal data, we comply strictly with the statutory provisions of the European Data Protection Regulation 2016/679 (hereinafter “GDPR”). Within the scope of your participation at the EL@N Formation event, your personal data will only be collected, processed and used to the extent permitted by law or permitted through your consent. This also applies to the disclosure of personal data.



a) Personal data

The following personal data is processed for the purposes listed in section b):

- Function (optional)
- Street, postcode, location, country (optional)

b) Purposes of the processing

The above-mentioned data will be processed by us or by a third party instructed to do so for purposes of conducting the registration and the execution of the event as well as the fulfilment of the contract with you.

c) Legal basis

The legal basis for data processing is Article 6 (1) (b) (for the participation) and (f) (for live streaming) of the GDPR. The legitimate interest for the film recordings lies in the execution of the training of external participants. Filming the participants serves to capture the atmosphere in the conference room and to present the event to the participants via live stream in an interesting and stimulating way. You have the right to object. This can be done at any time by contacting registration@bnotk.de.

4. Duration of personal data storage

We store your personal data strictly as long as necessary for the purposes for which it was acquired and in accordance with this data protection agreement. Your data will be stored for eight weeks after the end of the event. Film recordings will be not saved.

5. Information disclosure

The disclosure of your personal data to a third party for any other purposes than those about to be mentioned will not take place:

7. Right to appeal
